Laboratory Procedures

The vial contains an 8.82 M solution of hydrogen peroxide. The Antioxidant Assay Hydrogen Peroxide, when stored as supplied, is stable for one year at 4°C. For use in the Antioxidant Assay Kit (Catalog No. 709001), dilute 10 µl of hydrogen peroxide with 990 µl of HPLC-grade water. Remove 20 µl of this reagent and dilute with 3.98 ml of HPLC-grade water to yield a 441 μM working solution. The hydrogen peroxide working solution is stable for four hours at room temperature.

For laboratory research use only. This reagent is not for human or veterinary use. Hydrogen peroxide is corrosive and is harmful if swallowed. Contact with skin may cause burns. In case of contact with skin or eyes, rinse immediately with plenty of water for 15 minutes. Keep away from combustible materials. This product has been tested and formulated to work exclusively with the Antioxidant Assay Kit from Cayman Chemical Company (Catalog No. 709001). This product may not perform as described if used with other assay reagents or protocols.
