Laboratory Procedures

Microcystin-RR is supplied as a film. A stock solution may be made by dissolving the microcystin-RR in the solvent of choice, which should be purged with an inert gas. Microcystin-RR is soluble in the organic solvent methanol. It is also soluble in ethanol:water. We do not recommend storing the aqueous solution for more than one day.

Description

Microcystin-RR is a cyanotoxin and an inhibitor of protein phosphatase 1C (PP1C), PP1y, and PP2A (K,s = 0.15, 0.24, and 0.018 nM, respectively).¹ Intratracheal administration of microcystin-RR $(1,200 \ \mu g/kg)$ induces hepatic bleeding in mice. Microcystin-RR has been found in freshwater with cyanobacterial blooms.²
