

Laboratory Procedures

3-O-methyl-N-acetyl-D-Glucosamine (3-O-methyl-GlcNAc) is supplied as a crystalline solid. A stock solution may be made by dissolving the 3-O-methyl-GlcNAc in the solvent of choice, which should be purged with an inert gas. 3-O-methyl-GlcNAc is soluble in organic solvents such as DMSO and dimethyl formamide. The solubility of 3-O-methyl-GlcNAc in these solvents is approximately 30 mg/ml.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. Organic solvent-free aqueous solutions of 3-O-methyl-GlcNAc can be prepared by directly dissolving the crystalline solid in aqueous buffers. The solubility of 3-O-methyl-GlcNAc in PBS, pH 7.2, is approximately 1 mg/ml. We do not recommend storing the aqueous solution for more than one day.

Description

3-O-methyl-GlcNAc is a competitive inhibitor of N-acetylglucosamine kinase and a non-competitive inhibitor of N-acetylmannosamine kinase (K_i s = 17 and 80 μ M in rat liver, respectively, in vitro).¹
