#### Laboratory Procedures

ent-8-iso Prostaglandin F2a-d9 (ent-8-iso PGF2a-d9) is intended for use as an internal standard for the quantification of ent-8-iso PGF<sub>2a</sub> (Item No. 10011545) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

ent-8-iso  $PGF_{2a}$ -d<sub>9</sub> is supplied as a solution in acetonitrile. To change the solvent, simply evaporate the acetonitrile under a gentle stream of nitrogen and immediately add the solvent of choice. Solvents such as ethanol, DMSO, and dimethyl formamide purged with an inert gas can be used. The solubility of ent-8-iso PGF<sub>2a</sub>-d<sub>9</sub> in these solvents is approximately 100 mg/ml.

#### Description

Isoprostanes are produced by the non-enzymatic, free-radical peroxidation of arachidonic acid. They have been used as biomarkers of oxidative stress, but they also have been found to have a potent biological activity. ent-8-iso  $PGF_{2\alpha}$  is a potent vasoconstrictor of porcine retinal and brain microvessels with  $EC_{50}$ values of 31 and 54 nM, respectively.1
