

### Description

JWH 073 6-hydroxyindole metabolite-d<sub>7</sub> (Item No. 10719) is intended for use as an internal standard for the quantification of JWH 073 6-hydroxyindole metabolite (Item No. 9000863) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

JWH 073 is a mildly selective agonist of the central cannabinoid (CB<sub>1</sub>) receptor derived from the aminoalkylindole WIN 55,212-2. The K<sub>i</sub> values for binding CB<sub>1</sub> and the peripheral cannabinoid (CB<sub>2</sub>) receptor are 8.9 and 38 nM, respectively for a CB<sub>1</sub>:CB<sub>2</sub> ratio of 0.23.<sup>1</sup> JWH 073 is one of several synthetic CBs which have been included in smoking mixtures. JWH 073 6-hydroxyindole metabolite is expected to be a urinary metabolite of JWH 073 based on the metabolism of the closely-related JWH 015 and JWH 018.<sup>2,3</sup> This product is intended for forensic and research applications.
