Butalbital-d₅ (Item No. 15800) is intended for use as an internal standard for the quantification of butalbital (Item No. 15788) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Butalbital is characterized as a barbiturate.¹ Butalbital-d₅ is regulated as a Schedule III compound in the United States. This product is intended for research and forensic applications.
