The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Pentobarbital is categorized as a barbiturate.^{1,2} Pentobarbital- d_5 is regulated as a Schedule II compound in the United States. This product is intended for research and forensic applications.
