### Laboratory Procedures

Orexin 2 receptor agonist is supplied as a crystalline solid. A stock solution may be made by dissolving the orexin 2 receptor agonist in the solvent of choice, which should be purged with an inert gas. Orexin 2 receptor agonist is soluble in organic solvents such as DMSO and dimethyl formamide (DMF). The solubility of orexin 2 receptor agonist in these solvents is approximately 20 and 25 mg/ml, respectively.

Orexin 2 receptor agonist is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, orexin 2 receptor agonist should first be dissolved in DMF and then diluted with the aqueous buffer of choice. Orexin 2 receptor agonist has a solubility of approximately 0.16 mg/ml in a 1:5 solution of DMF:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

#### Description

Orexin 2 receptor agonist is an agonist of the orexin 2 receptor (OX2R) with an EC<sub>50</sub> value of 23 nM in a calcium influx assay.<sup>1</sup> It is 70-fold selective for OX2R over OX1R ( $EC_{50} = 1,616$  nM).
