Drimentine A is supplied as a solid. A stock solution may be made by dissolving the drimentine A in the solvent of choice. Drimentine A is soluble in organic solvents such as ethanol, methanol, DMSO, and dimethyl formamide, which should be purged with an inert gas.

Description

Drimentine A is a terpenylated diketopiperazine originally isolated from Actinomycete bacteria.¹ Unlike drimentine B (Item No. 25451) and drimentine C (Item No. 25763), drimentine A does not have anticancer activity.
