Laboratory Procedures

Ac-IETD-pNA is supplied as a lyophilized powder. A stock solution may be made by dissolving the Ac-IETD-pNA in the solvent of choice. Ac-IETD-pNA is soluble in the organic solvent formic acid, which should be purged with an inert gas, at a concentration of approximately 1 mg/ml.

Description

Ac-IETD-pNA is a substrate for caspase-8.1 Caspase-8 preferentially binds to and cleaves the Ile-Glu-Thr-Asp (IETD) peptide sequence to release p-nitroalinide, which can be quantified by colorimetric detection at 405 nm as a measure of enzyme activity.
