# Laboratory Procedures

EOS200271 is supplied as a crystalline solid. A stock solution may be made by dissolving the EOS200271 in the solvent of choice, which should be purged with an inert gas. EOS200271 is soluble in organic solvents such as DMSO and dimethyl formamide. The solubility of EOS200271 in these solvents is approximately 30 mg/ml.

EOS200271 is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, EOS200271 should first be dissolved in DMSO and then diluted with the aqueous buffer of choice. EOS200271 has a solubility of approximately 0.25 mg/ml in a 1:3 solution of DMSO:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

# Description

EOS200271 is an inhibitor of indoleamine 2,3-dioxygenase 1 (IDO-1; IC<sub>50</sub> = 0.15  $\mu$ M for the human enzyme).<sup>1</sup> It is selective for IDO-1 over IDO-2 up to a concentration of 200  $\mu$ M for the human recombinant enzymes. EOS200271 inhibits IDO-1-mediated production of kynurenine induced by IFN-γ in HeLa cells  $(IC_{50} = 1.8 \mu M)$  and by LPS and IFN- $\gamma$  in THP-1 cells and human-derived whole blood ex vivo  $(IC_{50} = 1.7 \mu M)$ and  $4.7 \,\mu$ M, respectively).
