Laboratory Procedures

1a-monohomo-17-phenyl trinor Prostaglandin $F_{2\alpha}$ is supplied as an oil. A stock solution may be made by dissolving the 1a-monohomo-17-phenyl trinor prostaglandin $F_{2\alpha}$ in the solvent of choice, which should be purged with an inert gas. 1a-monohomo-17-phenyl trinor Prostaglandin F_{2a} is soluble in organic solvents such as ethanol, acetonitrile, DMSO, and dimethyl formamide (DMF). The solubility of 1a-monohomo-17-phenyl trinor prostaglandin $F_{2\alpha}$ in ethanol and acetonitrile is approximately 50 and 3 mg/ml, respectively, and approximately 25 mg/ml in DMSO and DMF.

Further dilutions of the stock solution into aqueous buffers or isotonic saline should be made prior to performing biological experiments. Ensure that the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. Organic solvent-free aqueous solutions of 1a-monohomo-17-phenyl trinor prostaglandin $F_{2\alpha}$ can be prepared by directly dissolving the oil in aqueous buffers. The solubility of 1a-monohomo-17-phenyl trinor prostaglandin F_{2g} in PBS, pH 7.2, is approximately 0.25 mg/ml. We do not recommend storing the aqueous solution for more than one day.

Description

1a-monohomo-17-phenyl trinor Prostaglandin $F_{2\alpha}$ is a derivative of 17-phenyl trinor prostaglandin $F_{2\alpha}$ ethyl amide (Item No. 16820) and an isomer of 17-phenyl trinor prostaglandin $F_{2\alpha}$ methyl ester (Item No. 10010110).
