

## **Laboratory Procedures**

Reveromycin B is supplied as a lyophilisate. A stock solution may be made by dissolving the reveromycin B in the solvent of choice, which should be purged with an inert gas. Reveromycin B is soluble in organic solvents such as ethanol, methanol, DMSO, and dimethyl formamide.

Reveromycin B is sparingly soluble in aqueous solutions. To enhance aqueous solubility, dilute the organic solvent solution into aqueous buffers or isotonic saline. If performing biological experiments, ensure the residual amount of organic solvent is insignificant, since organic solvents may have physiological effects at low concentrations. We do not recommend storing the aqueous solution for more than one day.

### Description

Reveromycin B is a spiroketal bacterial metabolite originally isolated from Streptomyces. 1 It inhibits EGF-induced mitogenic activity in Balb/MK cells (IC $_{50}$  = 6  $\mu$ g/ml) and exhibits pH-dependent antifungal activity against C. albicans (MICs = 15.6 and >500 µg/ml at pH 3.0 and 7.4, respectively). Unlike reveromycin A (Item No. 17458) and reveromycin C (Item No. 23488), reveromycin B does not inhibit proliferation of KB and K562 cells.
