## **Laboratory Procedures**

Kresoxim-methyl is supplied as a solid. A stock solution may be made by dissolving the kresoxim-methyl in the solvent of choice, which should be purged with an inert gas. Kresoxim-methyl is slightly soluble in chloroform and methanol.

## Description

Kresoxim-methyl is a strobilurin fungicide.<sup>1</sup> It inhibits conidial germination of V. inaequalis isolates from apple orchards ( $EC_{50}s = 0.00033-0.0078 \text{ mg/L}$ ). Kresoxim-methyl also inhibits mycelial growth (EC<sub>50</sub> = 0.240 mg/L) and is fungicidal against Saprolegnia (MIC = 1 mg/L).<sup>2</sup> It increases intracellular calcium levels and disrupts the mitochondrial membrane potential in mouse cortical cultures in a concentration-dependent manner.<sup>3</sup> Kresoxim-methyl is toxic to goldfish (C. auratus; LC<sub>50</sub> = 0.807 mg/L).<sup>2</sup> Formulations containing kresoxim-methyl have been used in the control of fungi in agriculture.
