Laboratory Procedures

Territrem B is supplied as a solid. A stock solution may be made by dissolving the territrem B in the solvent of choice, which should be purged with an inert gas. Territrem B is soluble in the organic solvent DMSO.

Description

Territrem B is a mycotoxin originally isolated from A. terreus that irreversibly inhibits acetylcholinesterase (AChE; IC_{50} = 19 nM for the electric eel enzyme).¹ It is toxic to mice, inducing tremors with a median tremulous dose of 0.21 mg/kg, and has an LD₅₀ value of 9.06 mg/kg.²
