Laboratory Procedures

1,3-Dinervonoyl glycerol is supplied as a solid. A stock solution may be made by dissolving the 1,3-dinervonoyl glycerol in the solvent of choice, which should be purged with an inert gas. 1,3-Dinervonoyl glycerol is soluble in organic solvents such as ethanol and dimethyl formamide. The solubility of 1,3-dinervonoyl glycerol in these solvents is approximately 10 mg/ml.

1,3-Dinervonoyl glycerol is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, 1,3-dinervonoyl glycerol should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. 1.3-Dinervonoyl glycerol has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Description

1,3-Dinervonoyl glycerol is a diacylglycerol that contains nervonic acid (Item No. 13940) at the sn-1 and sn-3 positions.
