

## **Laboratory Procedures**

Didocosahexaenoin is supplied as a liquid. A stock solution may be made by dissolving the didocosahexaenoin in the solvent of choice, which should be purged with an inert gas. Didocosahexaenoin is soluble in organic solvents such as ethanol and dimethyl formamide. The solubility of didocosahexaenoin in these solvents is approximately 10 mg/ml. Didocosahexaenoin is also slightly soluble in chloroform.

Didocosahexaenoin is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, didocosahexaenoin should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. Didocosahexaenoin has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Didocosahexaenoin is a diacylglycerol that contains docosahexaenoic acid (DHA; Item No. 90310) at two
