## Laboratory Procedures

1,2-Dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol is supplied as an oil. A stock solution may be made by dissolving the 1,2-dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol in the solvent of choice, which should be purged with an inert gas. 1,2-Dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol is soluble in organic solvents such as ethanol and dimethyl formamide. The solubility of 1,2-dipalmitoleoyl-3-11(Z)octadecenoyl-rac-glycerol in these solvents is approximately 10 mg/ml.

1,2-Dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, 1,2-dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. 1,2-Dipalmitoleoyl-3-11(Z)-octadecenoylrac-glycerol has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

## Description

1,2-Dipalmitoleoyl-3-11(Z)-octadecenoyl-rac-glycerol is a triacylglycerol that contains palmitoleic acid (Item Nos. 10009871 | 21911) at the sn-1 and sn-2 positions and cis-vaccenic acid (Item No. 20023) at the sn-3 position.
