

Laboratory Procedures

Spinosyn D aglycone is supplied as a solid. A stock solution may be made by dissolving the spinosyn D aglycone in the solvent of choice, which should be purged with an inert gas. Spinosyn D aglycone is soluble in organic solvents such as ethanol, methanol, DMSO, and dimethyl formamide.

Description

Spinosyn D aglycone is an aglycone form of the insecticide spinosyn D (Item No. 19158).¹ Unlike spinosyn D, spinosyn D aglycone is not lethal to H. virescens (tobacco budworm) neonate larvae $(LC_{50} = >64 \text{ ppm}).$
