Laboratory Procedures

Palmitic acid-¹³C (C2 labeled) is supplied as a crystalline solid. A stock solution may be made by dissolving the palmitic acid- 13 C (C2 labeled) in the solvent of choice, which should be purged with an inert gas. Palmitic acid-¹³C (C2 labeled) is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of palmitic acid-¹³C (C2 labeled) in ethanol is approximately 30 mg/ml and approximately 20 mg/ml in DMSO and DMF.

Palmitic acid-¹³C (C2 labeled) is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, palmitic acid-13C (C2 labeled) should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. Palmitic acid- 13 C (C2 labeled) has a solubility of approximately 0.25 mg/ml in a 1:10 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Description

Palmitic acid-¹³C is intended for use as an internal standard for the quantification of palmitic acid (Item No. 10006627) by GC- or LC-MS. Palmitic acid is a common 16-carbon saturated fat that represents 10-20% of human dietary fat intake and comprises approximately 25 and 65% of human total plasma lipids and saturated fatty acids, respectively.^{1,2} Acylation of palmitic acid to proteins facilitates anchoring of membrane-bound proteins to the lipid bilayer and trafficking of intracellular proteins, promotes protein-vesicle interactions, and regulates various G protein-coupled receptor functions.¹ Red blood cell palmitic acid levels are increased in patients with metabolic syndrome compared to patients without metabolic syndrome and are also increased in the plasma of patients with type 2 diabetes compared to individuals without diabetes.^{3,4}
