1,3-Dipalmitoyl-2-myristoyl glycerol is supplied as a crystalline solid. A stock solution may be made by dissolving the 1,3-dipalmitoyl-2-myristoyl glycerol in the solvent of choice, which should be purged with an inert gas. 1,3-Dipalmitoyl-2-myristoyl glycerol is soluble in the organic solvent chloroform at a concentration of approximately 10 mg/ml.

Description

1,3-Dipalmitoyl-2-myristoyl glycerol is a triacylglycerol that contains palmitic acid (Item No. 10006627) at the sn-1 and sn-3 positions and myristic acid (Item No. 13351) at the sn-2 position. It has been found in palm oil.¹
