Laboratory Procedures

1,2-Dioleoyl-3-arachidonoyl-rac-glycerol is supplied as an oil. A stock solution may be made by dissolving the 1,2-dioleoyl-3-arachidonoyl-rac-glycerol in the solvent of choice, which should be purged with an inert gas. 1,2-Dioleoyl-3-arachidonoyl-rac-glycerol is soluble in organic solvents such as ethanol, chloroform, and dimethyl formamide (DMF). The solubility of 1,2-dioleoyl-3-arachidonoyl-rac-glycerol in ethanol and DMF is approximately 10 mg/ml. 1,2-Dioleoyl-3-arachidonoyl-rac-glycerol is slightly soluble in choloroform.

1,2-Dioleoyl-3-arachidonoyl-rac-glycerol is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, 1.2-dioleoyl-3-arachidonoyl-rac-glycerol should first be dissolved in ethanol and then diluted with the aqueous buffer of choice. 1,2-Dioleoyl-3-arachidonoyl-rac-glycerol has a solubility of approximately 0.5 mg/ml in a 1:1 solution of ethanol:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Description

1,2-Dioleoyl-3-arachidonoyl-*rac*-glycerol is a triacylglycerol that contains oleic acid (Item Nos. 90260 | 24659) at the sn-1 and sn-2 positions and arachidonic acid (Item Nos. 90010 | 90010.1 | 10006607) at the sn-3 position.
