## **Laboratory Procedures**

N<sup>4</sup>-Benzoyl-5'-O-(4,4'-dimethoxytrityl)-2'-deoxycytidine is supplied as a solid. A stock solution may be made by dissolving the N<sup>4</sup>-benzoyl-5'-O-(4,4'-dimethoxytrityl)-2'-deoxycytidine in the solvent of choice, which should be purged with an inert gas. N4-Benzoyl-5'-O-(4,4'-dimethoxytrityl)-2'-deoxycytidine is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide. The solubility of N4-benzoyl-5'-O-(4,4'-dimethoxytrityl)-2'-deoxycytidine in these solvents is approximately 30 mg/ml.

### Description

N<sup>4</sup>-Benzoyl-5'-O-(4,4'-dimethoxytrityl)-2'-deoxycytidine is a building block that has been used in the synthesis of oligodeoxyribonucleotides. 1,2
