# Laboratory Procedures

Dihydrophytol is supplied as a neat oil. A stock solution may be made by dissolving the dihydrophytol in the solvent of choice, which should be purged with an inert gas. Dihydrophytol is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of dihydrophytol in ethanol and DMF is approximately 10 mg/ml and approximately 5 mg/ml in DMSO.

# Description

Dihydrophytol is an intermediate in the biosynthesis of phytanic acid (Item No. 90360).<sup>1</sup> It is produced from phytol (Item No. 17401) in the rumen of cattle.<sup>2</sup>
