Fludiazepam-d₄ (Item No. 32538) is an analytical reference standard intended for use as an internal standard for the quantification of fludiazepam (Item No. 22424) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Fludiazepam is categorized as a benzodiazepine.¹ Fludiazepam-d₄ is regulated as a Schedule IV compound in the United States. This product is intended for research and forensic applications.
