Laboratory Procedures

Benanomicin B is supplied as a solid. A stock solution may be made by dissolving the benanomicin B in the solvent of choice, which should be purged with an inert gas. Benanomicin B is soluble in the organic solvent DMSO.

Description

Benanomicin B is a microbial metabolite that has been found in Actinomycetes and has antifungal, fungicidal, and antiviral activities.^{1,2} It is active against a variety of mammalian and plant pathogenic fungi, including C. albicans, T. mentagrophytes, C. neoformans, and P. oryzae (MICs = 1.56-50 μg/ml).¹ Benanomicin B inhibits HIV-1 viral infection in MT-4 cells in a concentration-dependent manner.²
