Laboratory Procedures

28-Deoxybetulin methyleneamine is supplied as a crystalline solid. A stock solution may be made by dissolving the 28-deoxybetulin methyleneamine in the solvent of choice, which should be purged with an inert gas. 28-Deoxybetulin methyleneamine is soluble in ethanol and dimethyl formamide at a concentration of 1 mg/ml. 28-Deoxybetulin methyleneamine is also slightly soluble in DMSO.

Description

28-Deoxybetulin methyleneamine is a pentacyclic triterpenoid and derivative of the cholesterol biosynthesis inhibitor betulin (Item No. 11041).¹ It has been used in the synthesis of triterpene derivatives with antiviral activity.
