 $Psilocybin-d_{10}$ (Item No. 33761) is intended for use as an internal standard for the quantification of psilocybin (Item Nos. 14041 | 9003134) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Psilocybin-d₁₀ (Item No. 33761) is intended for use as an internal standard for the quantification of psilocybin (Item Nos. 9003134 | 14041) by GC- or LC-MS. Psilocybin is categorized as a tryptamine.^{1,2} It induces the head-twitch response (HTR) in mice, indicating hallucinogenic potential.² Psilocybin-d₁₀ is regulated as a Schedule I compound in the United States. This product is intended for research and forensic applications.
