BAY-885 is supplied as a solid. A stock solution may be made by dissolving the BAY-885 in the solvent of choice, which should be purged with an inert gas. BAY-885 is soluble in the organic solvent ethanol.

Description

BAY-885 is an inhibitor of ERK5 (IC $_{50}$ = 0.035 $\mu\text{M}).^1$ It inhibits ERK5-induced transcription in SN12C-MEF2 reporter cells (IC₅₀ = $0.12 \mu M$).
