Laboratory Procedures

Dabigatran-d₃ is intended for use as an internal standard for the quantification of dabigatran (Item No. 17133) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Dabigatran-d₃ is supplied as a solid. A stock solution may be made by dissolving the dabigatran-d₃ in the solvent of choice, which should be purged with an inert gas. Dabigatran-d₃ is slightly soluble in DMSO.

Description

Dabigatran is an inhibitor of thrombin ($K_i = 0.0045 \ \mu$ M) and an active metabolite of the thrombin inhibitor prodrug dabigatran etexilate (Item No. 17131).^{1,2} It also inhibits trypsin (K_i = 0.0503 μ M) but is selective for thrombin and trypsin over plasmin, Factor Xa, activated protein C, and tissue plasminogen activator (tPA; K_is = 1.695, 3.76, 20.93, and 45.36 μM, respectively).¹
