Montelukast is supplied as a solid. A stock solution may be made by dissolving the montelukast in the solvent of choice, which should be purged with an inert gas. Montelukast is soluble in organic solvents such as DMSO and dimethyl formamide. The solubility of montelukast in these solvents is approximately 2 mg/ml.

Description

Montelukast is a cysteinyl leukotriene 1 (CysL T_1) receptor antagonist (IC $_{50}$ = 4.9 nM in HEK293 cell membranes expressing the human receptor). It is selective for CysL T_1 over CysL T_2 receptors (IC₅₀ = >10,000 nM in COS-7 cell membranes expressing the human receptor).² Montelukast inhibits bronchoconstriction induced by leukotriene D₄ (LTD₄; Item No. 20310) in anesthetized guinea pigs (ED₅₀ = 69 nmol/kg, p.o.).³ It inhibits ovalbumin-induced airway hyperresponsiveness and increases in the number of total cells and eosinophils in bronchoalveolar lavage fluid (BALF) in a mouse model of allergic asthma when administered at doses of 3 and 10 mg/kg.4 Formulations containing montelukast have been used in the treatment of asthma, allergic rhinitis, and exercise-induced bronchoconstriction.
