(+)-Chloropseudoephedrine is a contaminant produced during the illicit manufacture of (+)-methamphetamine (Item No. 13997) when (+)-pseudoephedrine or (-)-ephedrine are used as precursors.^{1,2} Chloroephedrine has been reported to be present in varying levels in clandestinely synthesized methamphetamine and has been observed in some forensic samples.³ This product is intended for forensic and research purposes.
