Acetyl fentanyl-d<sub> $\epsilon$ </sub> (hydrochloride) (Item No. ISO00129) is an analytical reference material intended for use as an internal standard for the quantification of acetyl fentanyl (Item Nos. ISO00128 | ISO60128) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

Acetyl fentanyl is categorized as an opioid.<sup>1</sup> Acetyl fentanyl-d<sub>5</sub> is regulated as a Schedule I compound in the United States. This product is intended for research and forensic applications.
