- 4.2 Important Symptoms and Effects, Both Acute and Delayed:** Overexposure may cause: confusion, dermatitis, headache, drowsiness, dizziness, gastrointestinal disturbance, optic nerve damage (blindness), nausea, unconsciousness, vomiting, visual disturbance, weakness.
